Legal Rights

You agree that we may download and utilize Software from third parties and accept any applicable license agreements on your behalf. Backup Services & Potential Data Loss

While Little Dog Tech will make reasonable efforts to safeguard the contents (data) stored on your computer, you understand and agree that it is your responsibility to back-up the data, software, information or other files stored on your computer disks and/or drives if you so desire. You acknowledge and agree that Little Dog Tech and/or its third-party service provider shall not be responsible under any circumstances for any loss, alteration, or corruption of any software, data or files. Please note that Little Dog Tech does not guarantee that your data will be safe as Little Dog Tech does not accept any liability for loss of data stored on our internal workstations and/or servers.

Confidentiality

Little Dog Tech agrees not to disclose any and all information or data files supplied with, stored on, or recovered from your equipment except to employees or agents of Little Dog Tech subject to confidentiality agreements or as required by law.

Warranties

Little Dog Tech offers the following warranty periods. Dates that warranties become into effect are determined from the date stated on the invoice or receipt. Labor performed carries a 30-day warranty. If the same problem originally repaired re-occurs, Little Dog Tech will make a best effort to correct the fault originally repaired in a manner as decided as best by Little Dog Tech or its agents. New replacement parts used in the repair of a computer are warrantied for 30 days against defects or failure. Please refer to 'Limited Liability' for further information regarding component failure.
